In accordance with the ibid OM the revised pay scale of the post of Asstt. Accounts Officer in the Defence Accounts Department would be in Level 8 of the Pay Matrix and Level 9 on completion of 04 years in grade pay of Rs. 4800 (PB-2)/Level 8. This is a Non-Functional Upgradation (NFU), which is subject to the following terms and conditions:-

- Benefit of Pay Fixation as per Rule 13 of CCS (Revised Pay) Rules 2016 shall be available at the time of grant of NFU to AAOs.
- NFU will be reckoned for financial upgradation under MACP Scheme. Subsequent financial upgradation under MACPS, if any, is to be reckoned from the date of grant of NFU.
- This supersedes all earlier Part II Office Orders on MACPS already granted to the effected AAOs after 01.01.2016 in Pay Matrix Level-9 if any.
- After grant of NFU to AAOs in pay level-9 and their pay fixation under Rule 13 of CCS (RP) Rules, 2016, there will be no further pay fixation on promotion to the post of Accounts Officer in Pay Level-9.

With regard to fixation of pay on grant of Non Functional Upgradation, option (Option form can be downloaded from CDA [Army] Meerut website) should be exercised to AN-III Section of Main Office within one month from the date of grant of NFU. Pay fixation will be carried out as per the extant rules on the subject.
