2. In accordance with the ibid OM the revised pay scale of the post of Asstt. Accounts Officer in the Defence Accounts Department would be in Level 8 of the Pay Matrix and Level 9 on completion of 04 years in PB-2 with grade pay Rs. 4800 of 6th CPC and corresponding pay matrix level-8. This is a Non-Functional Upgradation (NFU), which is subject to the following terms and conditions:-

- Benefit of Pay Fixation as per Rule 13 of CCS (Revised Pay) Rules 2016 shall be available at the time of grant of NFU to AAOs.
- After grant of NFU to AAOs in pay matrix level-9 and pay fixation under Rule 13 of CCS (RP) Rules, 2016, there will be no further pay fixation on promotion to the post of Accounts Officer in Pay matrix level-9.
- NFU will be reckoned for financial up-gradation under MACP Scheme. Subsequent financial up-gradation under MACPS, if any, is to be reckoned from the date of grant of NFU.
- This supercedes all earlier Part II Office Orders on MACPS already granted to the effected AAOs after 01.01.2016 in Pay Matrix Level-9 if any.

3. With regard to fixation of pay on grant of Non Functional Upgradation, option (Option form can be downloaded from CDA [Army] Meerut website) should be exercised to AN-III Section of Main Office within one month from the date of publication of this Part II O.O. Pay fixation will be carried out as per the extent rules on the subject.
