
- 2. For solving the frequent slowdown of Tulip PMS servers, a third server has been added for Tulip PMS by HQrs office. Therefore, as per the instruction issued by HQrs office for distribution of servers across offices, CDA (Army) Meerut is required to access the Tulip Server on IP 10.48.153.7.
- 3. It is also informed that as per HQrs letter GeM online bills will be available only on IP: 10.48.153.6. Thus, the users processing the GeM bills are required to access the Tulip PMS on this IP only.
- 4. Therefore, all officer in charge are requested to access the Tulip PMS on appropriate IP address from now onwards.
