This may be brought to the notice of all candidates.**

4. In order to ensure transparency & fair conduct of Examination, it has been decided by the Competent Authority to Video-graph the entire proceedings of the Examination during all five papers. This may also be brought to notice of all the candidates.


5. Further, PCDA(BR) Delhi Cantt. has been nominated as the Conducting Officer of the examination. Printed Answer Books/Continuation Sheets in respect of each Paper i.e. Paper-V, VI, VII, VIII & IX shall be supplied from the HQrs. Office to the Conducting Officer. The Conducting Officer of the Examination Centre has to ensure following in respect of Practical Portion of Paper-IX – Fundamentals of EDP:-

- To make available a workable P.C. fitted with necessary software installed and necessary accessories to each candidate in the examination hall.
- To supply of a good quality CD to each candidate with necessary packing guard.

- (c) To take an additional copy of each candidate's answers on a PC to be kept safe under their personal custody till further orders from HQrs office.
- (d) To keep answers of each candidate in a CD as a back-up to be sent to HQrs office along with Answer Books. The extra back-up taken, shall have to be disposed of after hearing from the HQrs. Office.

PCDA(BR) ,Naraina, Ring Road, Delhi Cantt.	<p>In continuation of HQrs Office Circular No AN/SAS/16102/SAS-II/Sept/2023/CO dated 04/08/2023 necessary arrangement for digital videography of the examination through hiring or otherwise depending on the viability after following laid down procedure may be made. In case facility of videography is already available in your office/venue it may be ensured that the same is in workable condition with necessary back-up to avoid last minute glitches. Following instructions may be taken into consideration while going for videography: -</p> <ul style="list-style-type: none"> (i) The video recording of the proceedings of the examination should preferably be through indoor fixed HD resolution CCTV or equivalent camera with audio/sound. The recording must be of good quality resolution i.e, it should be possible to identify the individual without any difficulty. (ii) Video coverage of activity at examination hall/rooms to be used should be 15 minutes prior to commencement of the examination till completion. The coverage should also include recording of opening of question papers and sealing of answer packets for dispatch to HQrs Office. Further, <u>it may be ensured that date and time are invariably displayed on recording while viewing.</u> (iii) There should be sufficient recording storage per day in order to ensure continuous and uninterrupted recording with time and date. (iv) DVD for each paper/day of the examination shall be prepared in movie mode playable on PC supported by common media player. <u>No editing of the recording is to be made.</u> (v) DVD should be in copy protection mode and are required to be submitted within three days after termination of examination for all the five days mentioning date, paper etc. of the examination on cover.

		<p>(vi) In case examination is being conducted at more than one hall, recording of each examination hall is to be made separately.</p> <p>(vii) The back-up of the recordings may be taken up by the Conducting Officer and may be disposed of only on hearing from HQrs office or after completion of one year of the examination whichever is earlier.</p> <p>2. <u>Paper IX i.e. Fundamentals of EDP (Practical Portion)</u> :</p> <p>It is requested to ascertain from the candidates, the type of Window Operating System, MS Office version etc. they may prefer to attempt practical portion of Paper IX- Fundamentals of EDP and accordingly provide the same.</p> <p>3. Arrangement for smooth and fair conduct of examination including that of practical portion of Paper IX may be confirmed.
