- 2. In this context, it is informed that the SVEEP (Systematic Voters' Education and Electoral Participation) Division of the Election Commission of India conducts SSR every year for the enrolment of young voters, de-duplication activities and purification of electoral rolls. The SSR provides an opportunity to newly eligible citizens (those completing the age of 18 years on or will also be received from 17+ citizens completing the age of 18 years w.r.t subsequent opportunity to purify the electoral rolls by deleting the name of deceased and permanently shifted voter by filing Form-7.
