

Subject- Timely completion of APAR for the year 2022-23 on SPARROW.

With reference to the subject cited above, it has been observed that the APARs are not completed by the officers/staff as per the laid down DoPT timelines. This has been viewed seriously by the Competent Authority.

- In this regard, it is stated that the Officers whose APAR is pending on SPARROW at the level of Self-Appraisal are requested to forward the same to their Reporting Authority **immediately**. On failure of an officer/staff to submit Self-Appraisal as per above to the Reporting Officer, the same will be "Force Forward" to the Reporting Officer without Self-Appraisal. - 3. The Reporting Officers are requested to keep a watch on the movement of APARs of officer/staff working under them and ensure that the APARs are written timely. In case, the Self-Appraisal is not submitted timely, then the force forwarded APAR without Self-Appraisal shall be written by the Reporting Officer.
