As per HQrs office important circular No. AN/VI/17003/DAD(SAS) OA/2023-24 dated-09-03-2023 wherein guidelines for conduct of exercise of options for verification of membership of Staff Association & DAD (SAS) Officers' for the year 2023-24 through check off system have been issued.

2. In this context, the Competent Authority vide letters no. AN/VI/17003/DAD (SAS) OA/2023-24 Dt.-21-04-2023 & AN/VI/17003/Staff Association/2023-24 Dt.-04-05-2023 has already been decided **to extend the time schedule of event** for exercise of option and verification of membership of association upto 31 July 2023 which may result into delay in verification of membership strength of associations from the pay bill for the month of July 2023.
3. Further HQrs office letter cited under reference that the verification of membership of association must be completed by deduction of annual subscription form pay roll in favour of the particular Association by the DDO in the month of July 2023. The controller may decide a different time schedule adequately in advance for completion of exercise of option so as to ensure deduction of subscription by DDO in the month of July 2023 itself and verification of membership of association from the pay bills of July, 2023.
4. So, a detailed report indicating complete details of the number of employees, total membership strength & strength of office should reach this office (CDA (Army), Meerut **by 10 July 2023** for deduction of subscription by DDO in the month of July 23 and verification of membership of association from the pay bill of July 2023, for onward submission to HQrs Office timely.
5. It is requested that the deadlines intimated by HQrs office may be strictly adhered to.
