Grant of Higher Grade under MACP scheme shall be conditional to the fact that an employee while accepting the said benefit shall be deemed to have given his/her unqualified acceptance for regular promotion on occurrence of vacancy subsequently. In case he/she refuses to accept the higher post and regular promotion subsequently, he/she shall be subject to normal debarment for further financial up-gradation till he/she agrees to be considered for promotion again as prescribed in Para 25 of Annexure-I to the above letter of DOP&T for grant of benefits under MACP scheme.

The placement in the immediate higher grade pay/ Grant of financial benefits through up-gradation under MACP scheme is only on personal basis and shall therefore neither amount to financial/regular promotion nor change in the existing designation or seniority position. Their pay shall be fixed under the provision of FR-22(I)a(1). The financial benefit allowed under MACP scheme shall be final.

The pay of the individuals shown above who have completed 10 years, 20 years or 30 years of service or 10 years continuous service in the same grade, shall be fixed under the provision of FR22(1) a (1) as per DOP&T vide No. 35034/3/2008-Estt(D) dated 19-05-2009 with effect from the date mentioned against the name of the individuals.

The individual(s), if desire, to get their pay fixed in the scale under MACP scheme may exercise their option within one month from the date of issue of this order. Option certificate to this effect may be sent AN-III(Pay) of this office. Option once exercised shall be final.
