- 3. Accordingly it is requested to send the names of such officials who have passed Supervisory accounts examination held on 29.04.2002 latest by 24.07.2023 to forward their names to HQrs Office.
- 3. It may also be ensured that no eligible individual falling within the zone of consideration has been left out. If the eligible individual is left out the responsibility will be fixed in the name of forwarding authority.
- 3. Report must be forwarded to this office strictly by 24.07.2023 through E-mail. Nil report is also required.

- 3. In this connection, it is requested from all the Controllers to identify such officials who have passed Supervisory accounts examination held on 29/04/2002 and forward their names to this office.
- 4. It is also requested that all the Controllers may make concerted efforts to cull out the information from Service Documents/Dossiers of the individuals as per prescribed criteria mentioned at Para 2 and Para 3 above and prepare a roster of such eleigible employees in defined Annexure. An Excel file named Annexure 'A' is enclosed alongwith this Circular. This collated data/information may positively be forwarded to HQrs office latest by July 31st and also on E-mail i.e. hqanxi.dad@hub.nic.in
