She will be on probation for a period of two years from the date of their appointment in the first instance. She will have to give one month notice if she voluntarily resign from the service. Likewise, one month notice if the Govt. intend to terminate her service till the confirmation in Group 'C' class due to unsatisfactory work and character and for any other reasons three months notice shall be given to the individual.

It is also clarified that her appointment will be provisional, which will be regularized after verification of their Character & Antecedents. If their Character & Antecedents are not verified in the Police Verification Report or any information declared by her is found to be wrong, her appointment will be cancelled at the same time and legal action will be taken against her as appropriate.

She has been found physically fit for service in and out of India in medical examination done by competent Medical Officer.

During service she is mandatorily required to pass departmental confirmation test of typing test organized by Staff Selection Commission (Central Region), Prayagraj or Ministry of Home Affairs, Departmental of Official Language, New Delhi, otherwise their increment will be stopped and services are liable to be terminated.
