They will be on probation for a period of two years from the date of their appointment in the first instance. They will have to give one month notice if they voluntarily resign from the service. Likewise, one month notice shall be given to the individuals, if the Govt. Intend to terminate their service till the confirmation in Group 'C' class due to unsatisfactory work and character and for any other reasons three months notice shall be given to the individuals.

It is also clarified that their appointment will be provisional, which will be regularized after verification of their Character & Antecedents, If their Character & Antecedents are not verified in the Police Verification Report or any information declared by them is found to be wrong, their appointment will be cancelled at the same time and legal action will be taken against them as appropriate.
