He will be an probation for a period of two years from the date of his appointment in the first instance. He will have to give one month notice if he voluntarily resign from the service. Likewise, one month notice shall be given to the individual, if the Govt. intend to terminate his service till the confirmation in Group 'C' class due to unsatisfactory work and character and for any other reasons three months notice shall be given to him

It is also clarified that his appointment will be provisional, which will be regularized after verification of their Character & Antecedents. If his Character & Antecedents are not verified in the Police Verification Report or any information declared by him is found to be wrong, his appointment will be cancelled at the same time and legal action will be taken against him as appropriate.
